<p>From Monday 27th of November the ESES participants can contact Euroclear Belgium to reposition their Mdxhealth shares for trading on NASDAQ by fulfilling attached Repositioning Form in accordance with the procedure.</p> <p><u>Procedure</u></p> <p>To reposition your shares from the European market to the US market, please:</p> <ol style="list-style-type: none"> 1. complete the Repositioning Form “Euroclear Repositioning BE to US” in Annex 2. if the shares are to be delivered directly to a DTC participant, ensure the DTC participant is aware of repositioning request and is ready to submit their DWAC instruction 3. in case of bulk delivery, an Excel Spreadsheet can be joined to the Repositioning Form. This will only be usable if the delivery is all going to the same US DTC participant account (on behalf of multiple beneficial holder accounts) 4. send the Repositioning Form to: ebe.issuer@euroclear.com <p>If the Admitted Securities and the instructions are received by EBE prior to 4:00 pm EST on any day that Euronext is open for Business ("Business Day"), EBE will process the Repositioning on the BE Register same day on the best effort basis; if the Admitted Securities and the instructions are received by EBE after 4:00 pm EST on any Business Day, EBE will process the Repositioning on the BE Register the next Business Day on the best effort basis.</p> <p>Once your request is validated, we will contact the US transfer agent, Computershare and request them to credit the shares in the US market. If the request is to deliver the shares to a DTC participant, Computershare will deliver the shares to the DTC participant, noted on the Repositioning Form.</p> <p>If the request is to issue the shares directly on the US register a Direct Registration System ('DRS') statement will be issued and mailed from the US by Computershare to the shareholder. Note: the time difference will have an effect on the timing of the delivery in the US market.</p> <p><u>Tariff</u></p> <p>For each repositioning (credit/debit), a fee of EUR 17 will be applied by Euroclear Belgium. The US transfer agent, Computershare, will also apply its standard fees for each repositioning request to a DTC participant according to the value of the underlying shares. Computershare does not charge a fee if the request is to issue the shares directly on the US register in the shareholders name.</p>
